 - (e) Non Refundable registration fee Rs 5,000/- (Rupees Five Thousand Only) in the form of Demand Draft in favour of DSOI, Dhaula Kuan, Delhi from Scheduled Banks.
 - (f) Proof of Residence.
 - (g) Three photographs of the applicant and specimen signatures duly attested by Chartered Accountant/Gazetted Officer as per Performa.
 - (h) All documents submitted by the applicant must be signed with Ruber seal.
4. All existing contractors whose registration is expiring on 31 Mar 2010 also need to revalidate their registration by submitting the above mentioned documents.
